# RESEARCH ACTIVITIES

1. Since 2002 his main fieldwork concern the situation of Roma groups in Rome, both those living in authorised settlements and those living in shanty towns; his focus is on the scial organization of the Roma collectivity, the formation of a new romani ierarchies and leaderships in relation to the interaction with Italian society (local authorities and non-

profit sector). He worked on these items (power, relation with Italian society) in all of his research experience, both the one focused on Roma, and those on other migrant groups.

In 2004 he coordinated an interdisciplinary research group composed of scholars from several faculties of Università degli Studi Roma Tre. From December 2007 to February 2008 he conducted a research on the enforcement effects the Decree n. 181/2007 had in Rome; the research was commissioned by OSCE/ODHIR, who published the final report "The latest public enemy: romenia rom in Italy". Since May 2008, within a research program promoted by the Osservatorio sul Razzismo e le Diversità "M. G. Favara", he collected and analyzed legislative bills issued after the "Dichiarazione dello stato d'emergenza in relazione alla presenza di nomadi" in five Italian regions. Within this new policy framework, he focused on the Roma leadership that is collaborating with the local administration for the implementation of the "Nomads Plan" in Rome. From april to october 2010 he coordinated a research group engaged in the analysis of the situation of the Roma children in the Children Protection System; this activity was part of an international research project run by E.R.R.C. and financed by the U.E.

- 2. From May 2006 to January 2008 he carried out a research on the conditions and needs of migrant people living in the territory of VI Municipio in Rome, within a project aiming at developing active citizenship promoted by Osservatorio sul Razzismo e le Diversità 《M.G. Favara》 and financed by the XIX Department of the Municipality of Rome. He focused on the Bengali community associations and their relationship with local authorities.
- 3. From March 2007 to June 2008 he collaborated in the research activities within the project "Descolarizzazione, marginalità e adolescenti: un'analisi di realtà territoriali urbane" coordinated by professor D'Agostino, Laboratorio Europeo di Sociologia dell'Educazione e delle Culture, Department of Educational Sciences, Università degli Studi Roma Tre.
- 4. In 2002 he coordinated a research group composed of practising students from the Master in Politiche dell'Incontro e della Mediazione culturale engaged in the analysis of migrant presences in the territory of XV Municipio in Rome with a specific focus on the access to public services.
